We agree to conduct ourselves at all times in a professional manner as to not embarrass our daughter or the Miss Nebraska Organization. We will ensure that our daughter will conduct herself in the proper manner at all times. We further understand that it is at the sole discretion of the State Pageant Little Sister Princess Coordinator & Executive Directors when an invitation will be extended to attend various activities with the local titleholder, including the extent of involvement of the princess in the production numbers at the state pageant. The director's decision will be based in whole or in part on whether the function is age appropriate and how beneficial it is to the mentoring process of the princess as well as other production factors regarding the princess's participation in production numbers. We understand it is not a competition, but one of a mentoring and learning process conducted by the Miss Nebraska Organization and agree to abide by all decisions made by the Miss Nebraska Organization relative to the Little Sister Princess Program. - Must attend all LS practices and events (with exception of illness or family emergency) June 4 - 10, 2017
- Must attend orientation event March 31, 2017
- Include \$100.00 application fee that will not be deposited prior to Feb. 20, 2017 (cash or check made to Miss NE Little Sisters which will be applied to total \$275 fee. If not selected, this fee will be refunded. If application is withdrawn by participant family and girl does not participate after application is accepted and contract is sent, the deposit is non refundable. No refunds after March 3, 2017 with the exception of severe illness or long term family emergency and will require Miss Nebraska board of directors approval.)
- If chosen, \$275.00 Little Sister fee will be paid in full by May 1, 2017.
- If chosen, an informational packet and contracts will be sent by March 3, 2017. Return of all contracts must be made by deadline in packet or alternate will be chosen.
